
Memorandum and Articles of Association

MEMORANDUM OF THE SOCIETY


1. Name of the Society : GEETANJALI EDUCATIONAL SOCIETY, NELLORE
2. Special features of the Society : The Society is established with a view to promote General, Technical, Medical, Legal or any other Professional and Scientific Education in order to give a boost to the morale in the younger generations of all Castes, Creed and Colour.
3. Location of the Office situated : # 23/ 812, Fathe Khan Pet, NELLORE - 524 003, SPSR Nellore District.
4. Jurisdiction : The Jurisdiction of the Society shall be extended to whole of the Andhra Pradesh.
5. Date of commencement : The Society shall function with effect from the date of its Registration.
6. Aims and Objectives of the Society:
 1. To establish, aid and maintain educational Institutions, Universities and other institutions, to impart education at all stages for the promotion of Engineering, Medicine, Computer, Law, Commerce, Literature, Arts and Sciences - and all other subjects to improve the quality for diffusion of useful knowledge for all communities.
 2. To provide free education to the poor talented pupil by spending 10% funds of the Society.
 3. To devise ways and means and accord facilities for candidates to specialize in all or any of the above subjects.
 4. To establish, run and manage Telugu and English Medium Schools, Colleges and other Educational Institutions.
 5. To try to offer Medical and Clinical facilities by opening the necessary Hospitals, X-Ray Institutions and to run, maintain Hospitals, Hostels and Residential Houses etc.

6. To establish similar colleges in the entire area of operation for imparting good education to the boys and girls without discrimination of caste, creed or colour.
7. To cater the Educational needs of the students of the entire area of operation of the Educational Society by starting Junior Colleges at various places by providing both English and Telugu medium, interned education and the Degree and PG Colleges etc., as decided by the Executive Committee from time to time.
8. To establish and maintain education institutions, professional and technological for the promotion of Literature, Art, Science and Technology, Engineering, Medicine, Computer Science, M.B.A, M.C.A., Teacher Training, B.Ed., Nurses Training, I.T.I., Polytechnic etc., as decided by the committee from time to time.
9. To devise ways and means and to provide facilities for candidates to specialize in the above subjects by establishing and maintaining Hostels, Libraries and Liason with the official and non official bodies.
10. To promote standards of Education in all its aspects.
11. To run all educational institutions according to the Andhra Pradesh Educational rules after obtaining the Government Recognition's and aid etc.
12. To seek application for State and Central Governments, University Authorities and other official bodies to run the various courses pertaining to the various Certificate Courses; Degrees and Diplomas.
13. To run and maintain Residential Colleges or even separate hostels boarding and lodging homes for the students of various institutions run by the Educational Society in different parts of the District.
14. To prepare students for Intermediate (M.P.C., Bi. P.C., H.E.C., C.E.C., M.E.C., etc.) and Degree examinations of concerned University and other Universities recognized by the University Grants Commission, Government of India by providing opportunities for the private candidates by running classes and also by means of postal correspondence courses if necessary.
15. To cooperate with other Societies in all aspects, as well as to work with other Institutions and Organisations in pursuit of all or any of the above objectives of the Society.
16. To award Certificates and Diplomas to students of various levels as well as to award talented teachers in recognition of their good work.
17. To provide quality education in Urban and Rural areas.

vii) General:

- a. That the title of the Society shall be irrevocable.
- b. The surplus funds of the society shall be invested in accordance with the provision of the section 13 (1) (d) RWS 11 (5) of the IT Act 1961 and which is registered under 12 (a) of the IT Act of 1961.
- c. The income and funds of the Society will be solely utilized towards the objects and no portion it will be used for payments to the members by way of profit.
- d. The benefits of the Society shall be open to all irrespective of caste, creed, religion, sex etc.
- e. No activities of the society shall be carried any where outside India.
- f. The society shall not carry on any activity with the object of earning a profit.

viii) Amendments:

No amendment to the Association bye-laws shall be carried-out without prior approval of the Commissioner of Income Tax.

No Amendment or alteration shall be made in purpose of the Association unless it is voted 2/3rd of its members present at a Special meeting convened for the purpose and confirmed by 2/3rd of the members present at a Second Special Meeting.


ix) Liability:

ix) Winding up:


In case the Association decides to wind up its activities then the properties and funds of the Association that will remain after full satisfaction of the liabilities of the Association will be transferred or paid to some other institutions or institution with similar aims and objects only. They will be determined by the votes of 3/5th of the members of the Association present personally or by proxy at the time of second special General Body Meeting in accordance with the Andhra Pradesh Societies Registration Act 35 of 2001 will be scrupulously followed:

In winding up of the Committee the properties and funds relating to it that will remain after the full satisfaction of all the liabilities of the Committee shall be transferred or paid or delivered to some other institution having similar aims and objects and registered with the Commissioner of Income Tax u/s 12A, 80G of the Income Tax Act.




